### 4. FIRST AID MEASURES

### 5. FIRE-FIGHTING MEASURES

- Suitable Extinguishing Media:** Water spray (fog), Foam
- Specific Hazards Arising from the Chemical:** Extremely flammable aerosol. Exposure to high temperature may cause containers to burst. Bursting aerosol containers may be propelled from fire at high speed.
